DIRECTIONS FOR USE

The treatment should be carried out at times when there is reduced wasp activity e.g. dusk. Begin by attaching the straw to the aerosol nozzle, this is essential to create the required aerosol jet application. Direct the jet towards the nest, beginning from a distance of about 3 metres. Spray until the nest and all visible wasps are contacted, and then move forward spraying continuously, until the jet can be discharged directly into the nest hole. For large nests, the whole aerosol should be discharged. Wasps are very rapidly immobilised due to the freezing action of the spray. Wasps flying in the vapour cloud around the nest become narcotised and will not sting. The heavier than air vapour within the nest traps and suffocates the occupants. The insecticidal component of the formulation kills larvae and any wasps that attempt to enter the nest after the solvent has evaporated.
